hereinafter referred to as First Party, enters into and makes an agreement with Upshur County Commissioner of Precinct No. 4.

Upshur County, Texas, and in order to get material to market it is necessary to use a portion of Upshur County roads located in Precinct No. 4., over which Commissioner has jurisdiction and obligation to maintain in good repair and both parties being aware of possible damage to said roads as a result of hauling on and over same enter into the following agreement.
