Commissioners Court met in special session with all members present.

Motion by David Loyd seconded by Tommy Eatherton to approve the minutes of the previous meeting. Motion carried.

George McClelland met with the court concerning the rural addressing and mapping for the 911 system. He stated that he had developed a low cost system for several other couties and then made some recommendations to the county. The list of recommendations is attached.

Motion by Gaddis Lindsey seconded by Tommy Eatherton to approve the permit application of Southwestern Bell Telephone to install a buried cable within ROW of White Oak Road. Motion carried, copy of permit attached and specifications and maps are on file in the county clerk's office.

Motion by Tommy Stanley seconded by Gaddis Lindsey to approve the special road use agreement by Bradley contractors to haul logs on Ginger, Dahlia and Lavender Roads. Motion carried, copy attached.

Motion by David Loyd seconded by Tommy Eatherton to approve the special road use agreement by John Davidson Logging to haul logs on Lemon Road. Motion carried, copy attached.

Motion by David Loyd seconded by Tommy Eatherton to approve the special road use agreement by Dunlap & Son to haul logs on Aspen Road. Motion carried, copy attached.

Motion by David Loyd seconded by Tommy Stanley to approve the permit application of Bruce Sanders to install a culvert within ROW of Ironwood Road. Motion carried, copy attached.

Motion by Tommy Eatherton seconded by David Loyd to approve the payroll changes of Teresa Kimbrough and Melvin Dodd. Motion carried, copy attached.

Motion by David Loyd seconded by Tommy Eatherton to approve payment of the bills now due. Motion carried, copy attached.

A bid was opened for land sold for taxes. Total taxes owed are 4,578.86 and the bid was from Vira Lange for 4,000.00. Motion by Tommy Eatherton seconded by Gaddis Lindsey to accept the bid. Motion carried, copy attached.

Judge Dean told the court about a person who had owned a mobile home and had never gotten a tax statement on it until just before he sold it. After he sold it, he was told by the appraisal district that he was responsible for all the taxes up to the present time. The man has said he will pay the part of the tax that is due for the time he owned it but will not pay for the other. It was decided to not do anything about this until the court had talked to the tax assessor and the appraisal district.

Motion by Tommy Eatherton seconded by Tommy Stanley to approve Ray Roeder as the ADA Co-Ordinator. He will be in charge of the buildings and grounds for the county. Motion carried.

RECOMMENDATIONS FOR UPSHUR COUNTY RURAL ADDRESSING

- Begin investigating possible financing methods for the addressing project.
- 2. Investigate methods to accomplish the project:
 - A. All work with Upshur County personnel
 - B. A turnkey project with an outside firm
 - C. Combination of the above.
- 3. Plan the Upshur County organization to accomplish the initial addressing and to maintain the system in the future. As a minimum there should be a Project Representative with overall responsibility for the project.
- 4. Appoint an Upshur County Rural Addressing Committee to begin planning and to develop county addressing standards for approval by the Commissioners Court. Representatives should include the following:
 - A. Law Enforcement

 - B. EMSC. Fire Departments
 - D. US Postal Service
 - E. Appraisal District
 - F. County Road & Bridge
 - G. Schools
 - H. Telephone Company
 - I. Other Utilities-Water, Gas, Power
 - J. General Public

This committee should also develop a definite plan to do the initial identification of rural residents as address assignment is accomplished

- 5. Begin work as soon as possible on the first essential phases:
 - A. A county road map with all road shown and identified by name or number
 - B. Erection of county road signs

In summary, a successful rural addressing project is difficult and time-consuming. Its success is dependent upon good planning and organization.
