RESOLUTION AUTHORIZING TAX RESALE



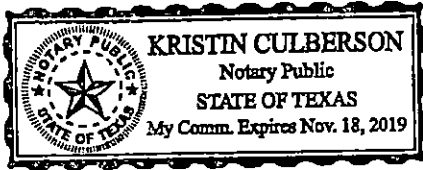
