

Bid Proposals

We had two proposal submitted, one from our current vendor, Sysco located in Longview Texas, and the other was from Performance Food Services located in Dallas Texas. In cost comparison both companies are close in cost with both companies being cheaper on certain items. The prices given from each company sometimes differed in size and packaging which could affect the cost comparison. After reviewing both bids both Sysco and Performance would be able to provide the basic requirements of the bid.

Rebates:

Both Sysco and Performance offer Rebates

Sysco offers 1.1% on Sysco Brand items for the year. Total Allowances for the 17-18 budget was approximately \$ 2100 dollars. Current budget year to date received 308.74

Performance provides a 2% rebate for the first 13 weeks for purchases over \$1500.

Averages weekly purchases range \$3600. To \$3800.
