





In this role at The Richards Group I played several parts, from project estimation and timing to application architecture and deployment. When looking at the initial scope of new projects, I would provide project managers with initial estimates of hosting requirements, technologies recommended and ballpark timing for project completion.

### Advance Auto Parts

Early on in 2011, in select markets Advance Auto Parts had rolled out a rewards incentive program that would let customers earn points through in store purchases. To participate customers would be asked to sign up at point of sale. Once they have completed their registration in-store, they would be given a Speed Perks keychain card to be swiped at point of sale before every purchase. Using the Speed Perks site, customers could see their rewards balance, the latest promotions, enter sweepstakes and update their account information. My role was to architect and build the back-end systems





needed for this project. Speed Perks is closely tied to an Advance Auto Parts partner First Data. I worked with one of First Data's developers to build out the site's integration into their systems. The client also partners with the email marketing company Silverpop. I worked with Silverpop to add Speed Perks members into their systems and trigger emails.

### The Home Depot



This is a one of a kind project. It allows the purchaser of a Home Depot video gift card to record a personalized video message for the recipient. The purchaser can record a message one of two ways. The most common way used was the webcam message recorder. I used Flash Media Server to facilitate this. The other way was to allow the purchaser to upload a video of their own. Before we could use their video with our video player, it must be encoded to the Flash video format. To do this, I designed a SAAS application which would play the role of encoding the uploaded videos into Flash video format. Once the video has been encoded, the application uploaded the video to a CDN and notifies the front-end site via an HTTP callback. This allows the recipient to view the video. For my work on this project, I was named the inventor of a Home Depot patent.

The goal of this site was to get the users interacting with their gift cards. The idea is that the user holds the card in front of their webcam. After the application detects the gift card, they are presented with what appears to be a 3D gift box sitting in front of their gift card using augmented reality. After they shake it, the front of the gift box pops open revealing a gift card purchase suggestion. To build the augmented reality portion of the site, I used the ActionScript library FlarManager. The gift crate is a Collada model which is an XML representation of a 3D model. The suggested items are managed via a custom product manager built for this project. Since product prices change from time to time, the product manager has routines which ensure these prices are up to date. This site launched 10/19/2009 and has had over 24,000 cards sold and over 2,000,000 in card sales.

The Chickfila cowz had long since needed their own site. This site allows views to see pictures and events, keep up with cow news, see the cowz twitter feed, and sign up for the newsletter. I served as technical lead with 2 in-house flash developers. There was a custom CMS built for this project which I used Ruby on Rails.
