# 8. Hear a Road Report from Andy Jordan. Discuss and take necessary action.

The Court heard a report from Andy Jordan, the Road Administrator. He explained in 2019 we had over 50 inches of rain in Upshur County so they weren't able to start oiling roads until June. They are still battling the same problems this year with all the recent rain. At this point they are only able to fix potholes because the ground is so saturated they can't afford to do any ditching without further damage. The Road Crews are cutting trees and patching roads as weather permits. A contractor was hired to come in and spray precinct two and precinct four with herbicides to control the grass problem since they are both more rural areas and this helps cut down on the mowing so they can concentrate more on the south end of the county which is more residential areas. They are waiting on the Legislature to release the rules for the TIF Grant. He has eight roads, in precinct one and precinct three, in mind that the \$800,000.00 will be spent on. So as fast as they can finish those eight roads and get the money turned back in that will put them in the running for more money. The next roads will be in precinct four and if there is a third allocation it

will be used in precinct two. If there isn't a third allocation, when they get their reimbursement back then they will begin their budget work in precinct two.

# 9. Hear from Employee Benefits Consulting concerning a four month financial review of Upshur County employee insurance benefits.

The Court heard a report from Rachel Means from Employee Benefits regarding cost and savings to the county. She said they have made a lot of progress since the renewal date of 10/01/2019. She takes the last two plan years and averages monthly what the county has been spending which has been running about \$255,000.00 on medical cost, pharmacy cost, stop loss and admin fees. At this point throughout the plan year the average is \$172,000.00 per month with lower deductibles and lower out of pocket cost. Rachel said she would budget for another shock claim. They had one come in for \$900,000.00 and they were able to negotiate it down to \$135,000.00. She believes conservatively the savings will be \$250,000.00 to \$300,000.00 by the end of the budget year.
