The Court heard from Marc Nichols and the committee regarding COVID-19. Mr. Nichols said there has been one case of the virus confirmed in Upshur County by the Department of State Health Services.

Julie York said there is a form for the Department Heads to fill out if anyone calls in sick so they can keep an eye on the situation with the employee.

The Judge said if a lot of people start calling in sick then the court may need to change their views on what action might be taken.
