A Special meeting of the Commissioners' Court of Upshur County, Texas was held on Wednesday, March 29, 2023 at 10:00 a.m., with the following members of the Court being present, to-wit:

Gene Dolle – Commissioner Pct. #1, Dustin Nicholson – Commissioner, Pct. 2, Mike Ashley – Commissioner Pct. #3, Jay W. Miller – Commissioner Pct. #4.

County Judge Todd Tefteller called the meeting to order at 10:00 a.m.

1. Invocation

Prayer was led by Gene Dolle.

2. Discuss and take action on selection of the construction delivery methods in connection with the Round XII Courthouse Renovation e.g. by seeking proposals for Comprehensive Contracts or by a Construction Manager at Risk system.

Appearing via Zoom were James Malanaphy with the Texas Historical Commission and Carl Komatsu with Komatsu Architecture. Rick Sacy with Komatsu Architecture was present with Hon. Leward LeFleur also being present. Hon. Judge LeFleur gave a brief overview to the Court of the difference between the construction delivery methods in connection with the courthouse renovation. James Malanaphy, Carl Komatsu, and Rick Sacy further described to the Court the differences between the methods and answered any questions the Court had in regards to same.

Motion by Dustin Nicholson with a second by Gene Dolle that the construction delivery method that Upshur County use is the CMAC method aka the Construction Manager as Contractor method. Motion carried 5-0. Unanimous vote in favor.

3. Hear updates and discuss and take necessary action concerning the Round XII Courthouse Grant Renovation and/or the Courthouse employee relocation during the renovation.

Judge LeFleur announced to the Court that an application had been submitted to Satellite for the modular office space. It looks like there will be plenty of space in this modular office space with the exception of using some of the space in the administration building to conduct other business such as commissioners court meetings and storage. Judge

Tefteller's office will be connected to the board room. Judge LeFleur hopes to get the office space delivered 30 -45 days from the date this project goes out for bids. He has suggested a tentative delivery date of June 1st. Mr. Rick Sacy will look into seeing if we can go out for qualifications now.
