

COMMISSIONERS COURT OF UPSHUR COUNTY, TEXAS
MONDAY, JULY 31, 2023
10:00 A.M. REGULAR SESSION

A regular meeting of the Commissioners' Court of Upshur County, Texas was held on Monday, July 31, 2023 at 10:00 a.m., with the following members of the Court being present, to-wit:

Judge Tefteller called the meeting to order at 10:00 a.m.

1. Invocation and Pledges

Prayer was led by Gene Dolle.

Pledges to the U.S. & Texas flags led by Dustin Nicholson.

2. Consider and take action on approval of:

- 6. Hear a brief presentation from Stuart Cobb with First National Bank of Wichita Falls, Texas about County Road & Bridge equipment inventory, financing and options available to the County to upgrade same.**

Stuart Cobb with First National Bank of Wichita Falls, Texas was present to discuss the options available to the County on the property that they had leased through First National Bank of Wichita Falls, Texas.

- 7. Discuss and take action to appoint a new member from Upshur County to the Community Healthcare Board of Trustees to serve a two-year term from September 1, 2023- August 31, 2025.**

Motion by Mike Ashley with a second by Dustin Nicholson to appoint Rick Lively to the Community Healthcare Board of Trustees to serve a two-year term from September 1, 2023 – August 31, 2025. Motion carried 5-0. Unanimous vote in favor.

- 8. Discuss and take action to approve and accept for recording the Interlocal Agreement for Assessment and Collection of Taxes between Upshur County and the Cities of Big Sandy, East Mountain, Warren City, Ore City, Gilmer and Emergency Services District #1.**

Motion by Jay W. Miller with a second by Mike Ashley to approve and accept for recording the Interlocal Agreement for Assessment and Collection of Taxes between Upshur County and the Cities of Big Sandy, East Mountain, Warren City, Ore City, Gilmer and Emergency Services District #1. Motion carried 5-0. Unanimous vote in favor.

- 9. Discuss and take action to set the salary of the elected County Sheriff at \$75,000/year, an increase of \$15,210 per year and to set the salary of all four (4) elected Constables at \$45,000/year, an increase of \$11,409 per year. Both increases are to meet the minimum salary requirements per Senate Bill 22 "Rural Law Enforcement Salary Assistance Grant."**

Motion by Gene Dolle with a second by Mike Ashley to set the salary of the elected County Sheriff at \$75,000/year, an increase of \$15,210 per year and to set the salary of all four (4) elected Constables at \$45,000/year, an increase of \$11,409 per year. Motion carried 5-0. Unanimous vote in favor.

- 12. Discuss and take action to accept a donation of pallets of water from Ozarka Water to Upshur County for the Road & Bridge Department and the Upshur County Maintenance Department.**

Motion by Mike Ashley with a second by Dustin Nicholson to accept a donation of pallets of water from Ozarka Water to Upshur County for the Road & Bridge Department and the Upshur County Maintenance Department. Motion carried 5-0. Unanimous vote in favor.

- 13. Hear from Road and Bridge Administrator concerning the storm cleanup and the current progress. Discuss and take necessary action.**

Phil Stegall, Upshur County Road and Bridge Administrator, advised the Court that they were at about 20% left to clean up. He advised the Court that they have also built two miles of road.

- 14. Consider, discuss and take action ratifying and extending the Declaration of Local Disaster Due to the June 2023 Thunder, Rain and Wind Storm dated June 16, 2023.**

Motion carried 5-0. Unanimous vote in favor.

- 10. Discuss and take action to approve filing of the FY2024 Proposed Budget no later than August 11, 2023 with the County Clerk and post to the Upshur County website in accordance with the Local Government Code Chapter 152.**

Motion by Dustin Nicholson with a second by Gene Dolle to approve filing of the FY2024

16. Hear any updates and discuss and take necessary action concerning the Round XII Courthouse Grant Renovation and/or the Courthouse employee relocation during the renovation.

Judge Leward Lefluer was present to provide an update to the Court. He announced that Texas had a surplus and elected to give more funding to this grant program. Upshur County could possibly get an additional 2.3 million dollars towards the renovation.

Motion carried 5-0. Unanimous vote in favor.

Motion by Gene Dolle with a second by Dustin Nicholson to authorize Judge Todd Tefteller to sign a contract for the construction of the Round XII renovation with J.C. Stoddard Construction Co. at such time as that contract has been read and approved by Judge Tefteller, Judge LeFleur and any of the Commissioners Court that wishes to have any input on the contract and the County Auditor's Office. Motion carried 5-0. Unanimous vote in favor.
