A regular meeting of the Commissioners' Court of Upshur County, Texas was held on Tuesday, August 15, 2023 at 10:00 a.m., with the following members of the Court being present, to-wit:

Judge Tefteller called the meeting to order at 10:00 a.m.

#### 1. Invocation and Pledges

3. Discuss and take action to approve the Contract with Debtbook for software to comply with GASB 87 and GASB 96 at a cost of \$8,000 for FY24, \$10,500 for FY25 and \$13,000 for FY26.

Motion by Dustin Nicholson with a second by Gene Dolle to approve the Contract with Debtbook for software to comply with GASB 87 and GASB 96 at a cost of \$8,000 for FY24, \$10,500 for FY25 and \$13,000 for FY26. Motion carried 5-0. Unanimous vote in favor.

5. Discuss and take action to approve the implementation of the Tyler Technologies Enterprise Corrections for the Sheriff's Office in conjunction with the implementation of the Court Management software previously approved by the Court.

Connie Williams, Upshur County Auditor, addressed the Court in regards to the importance of having the Jail on the same platform as the Criminal District Attorney, the District and County Clerks, and the Courts for various reasons but especially the CJIS reporting. She informed the Court that the one time implementation cost would run approximately \$172,000 (including travel and training) and the on-going annual maintenance would run \$66,000. She informed the court that the ARPA grant has accumulated approximately \$178,000 interest to date. She proposed a way to fund this and not use General Fund money would be to use the interest earned for the one time implementation cost. She also informed the Court that the Sheriff is willing to meet the same amount that both the District Clerk and the County Clerk offered which is \$50,000 each to go toward the cost of this which would pay for the majority of the first year's annual maintenance. Connie Williams further stated that for FY24 the actual cost to the general fund would be about \$16,000 if the court decides to go with that plan. Lt. Vanessa Ferguson addressed the Court and stressed the need for this software which would allow the efficient and beneficial flow with the Courts, Clerks and the District Attorney. John Galbraith with Tyler Technologies was also present to answer any questions that the Court might have regarding the software.

Motion by Gene Dolle with a second by Mike Ashley to approve the implementation of the Tyler Technologies Enterprise Corrections for the Sheriff's Office in conjunction with the implementation of the Court Management software previously approved by the Court. Motion carried 4-1 with Dustin Nicholson against.

6. Discuss and take action to approve essential vehicle repairs for the Sheriff's Office, in excess of the departmental budget for such repairs, be charged to Contingency account 100-409-4958.
