Judge Tefteller called the regular meeting to order at 10:00 a.m.

## 11. Hear any updates and discuss and take necessary action concerning the Round XII Courthouse Grant Renovation and/or the Courthouse employee relocation during the relocation.

Judge Tefteller updated those present with the status of the renovation. He said that there was a first meeting of subcontractors on Wednesday, September 13, 2023. Judge Tefteller was present with the Komatsu architecture, J.C. Stoddard contractor, Judge Leward LeFleur, Mike Ashley, and Gene Dolle.

#### **PUBLIC HEARING**

Public hearing opened at 10:38 a.m. by Judge Todd Tefteller.

**1.** Public Hearing on the Upshur County Clerk's Records Archive Plan and the Upshur County District Clerk's Records Archive Plan.

Nicole Hernandez, Upshur County District Clerk, presented her Archive Plan to the Court. She gave a brief update as to what she is working on in her office. She is working with a company to upload her microfilm into a cloud based software. This project should be completed by the end of the year or the beginning of next year. This will make documents from the 1800s to mid 1970's available on digital format. Her office is also hand scanning old civil and criminal cases. Her goal is to go paperless.

Terri Ross, Upshur County Clerk, presented her Archive Plan to the Court. She informed the Court that this Archive Plan is submitted annually to the Court to request the Court to allow her office to continue to collect the \$10.00 archive fee on documents filed in her official public records. She informed the Court that since she took office in 2015, she has been able to index and digitize 333 Deed Records, Oil and Gas Records, and Plat Records. These records are made available to search and purchase online. She also advised the Court that she is in year two of a four year project that includes indexing and digitizing all of the Deed of Trust Records and Mechanics and Materialman's Lien Records.

2. Public Hearing on the Proposed Tax Rate which is \$0.496 which is greater than the No-New Revenue Tax Rate of \$0.43666. Judge Tefteller explained to those present what the Court is proposing to do is to reduce the tax rate by approximately \$.10. Judge Tefteller went into detail what that would mean to the taxpayers. Judge Tefteller encouraged those present to ask questions should they have any concerns. There were several present that asked questions of the Court.
