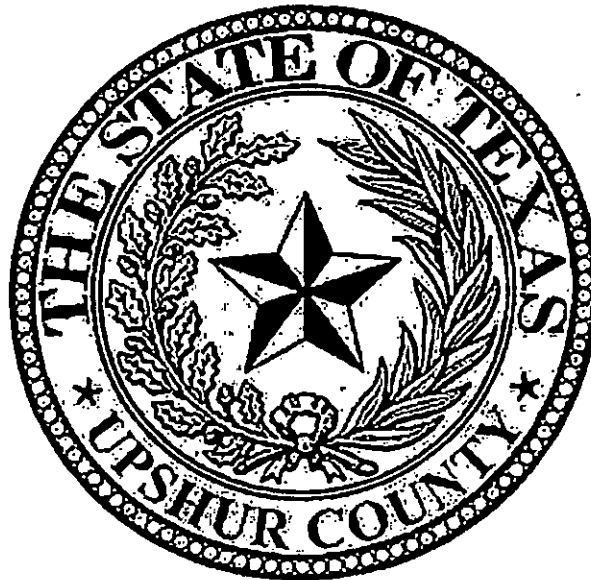

FINANCIAL HIGHLIGHTS

September 30, 2023 concludes Fiscal Year 2023 and I am pleased to report that we ended the year in a good position.

General Fund Revenue:

Eighty-five percent (85%) of the total general fund budgeted revenue comes from three categories, so it is critical that we stay on target in the following categories;

- **Current Taxes- FY 23 Budget \$ 12,582,142 which is 71% of total budget**
We collected \$ 12,576,542 in FY 23 or just slightly below budget by \$ 6K.
- **County Sales Tax- FY 23 Budget \$ 1,456,000 which is 10% of total budget**
We collected \$ 1.95 million in sales tax or \$ 491 K in excess of budget.
- **DMV and Tax Assessor Fees- FY 23 Budget \$ 940,000 which is 6% of total budget**

The Texas Comptroller remits a portion of the vehicle registration fee and the optional \$ 10 road and bridge fee to the County. We collected \$ 1.02 million in FY 23 or \$ 87K in excess of budget.

Total FY 23 Revenue from all sources exceeded budget by \$ 1.8 million.

1. Increase departmental budget \$ 21,000 for suspended District Clerk payout.

General Fund Expense:

All departments ended FY 23 under budget (in total), the following departments were greater than 20% under budget (well done!):

- o **County Court: ended FY 23 29K under budget due to 27K savings in Senate 7 attorney appointments.**
- o **Indigent Health: ended FY 23 \$ 141K under budget due in large part to the dedication and diligent management of the program by Ms. Ruth Whiteside.**

In total for all General Fund Departmental expenses, we ended FY 23 \$ 844K underbudget.

Insurance Fund

Insurance Claims, Prescriptions and Insurance Premiums ended the year \$ 243 K under budget in total.

Pooled Cash Report

As of September 30, 2023, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 22,285,754 of this amount \$ 14,366,345 belongs to the General Fund and \$ 7,919,409 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)

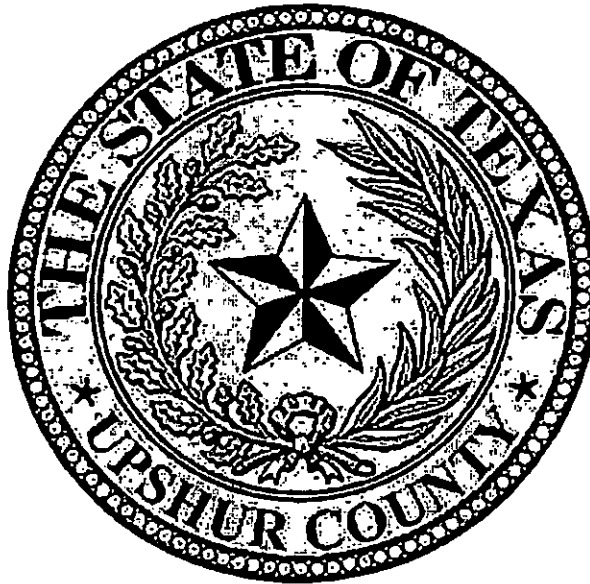

FINANCIAL HIGHLIGHTS

As of October 31, 2023 we have 11 months or 91.67% of the year remaining

General Fund Revenue:

Eighty-five percent (89%) of the total general fund budgeted revenue comes from three categories, so it is critical that we stay on target in the following categories;

- Current Taxes and penalties- FY 24 Budget is \$ 13,708,257 which is 75% of total budget

Through 10/31/2023 we have collected \$ 66K or less than 1% of budget. We are considerably behind collections at the same time last year which is a concern. However, I spoke with the tax assessor and apparently we were delayed in sending out tax notices thus large mortgage processing companies have not paid escrows yet and we should be receiving a few large payments beginning in November.

- County Sales Tax- FY 23 Budget \$ 1,600,000 which is 8.7% of total budget

Through 10/31/2023 we have collected \$ 148K or 9% of budget. At the same point last year we had collected 11% so we are slightly below last year.

- DMV and Tax Assessor Fees- FY 24 Budget \$ 940K which is 5% of total budget

The Texas Comptroller remits a portion of the vehicle registration fee and the optional \$ 10 road and bridge fee to the County. Through 10/31/2023 we have collected \$ 39K or 4% of the total budget.

General Fund Expense:

- With the following exceptions, all departments are at or above 91.67% of their remaining budget:
 - Tax Assessor- contracted service costs for property tax statements are incurred in October.

- Sheriff's Office- A purchase order in the amount of \$ 192K was issued for the purchase of 3 Chevy Tahoe's and 1 Chevy Silverado.
- Road and Bridge- Equipment Lease payments totaling \$ 190K were paid in October.
- Library- total budget for Library materials is \$ 45,000. Through October 31, the library has expended 8.5K or 19% of total budget

Insurance Fund

As of October 31, 2023 we have not received any Insurance claims from our new Insurance Administrator. We should be receiving claims in the next few weeks.

Pooled Cash Report

As of October 31, 2023, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 21,465,592 of this amount \$ 13,498,945 belongs to the General Fund and \$ 7,966,647 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)
