FINANCIAL HIGHLIGHTS

As of February 29, 2024 we have 7 months or 58 % of the year remaining

General Fund Revenue:

Eighty-nine percent (89%) of the total general fund budgeted revenue comes from three categories, so it is critical that we stay on target in the following categories;

- Current Taxes and penalties- FY 24 Budget is \$ 13,708,257 which is 75% of total budget

Through 02/29/2024 we have collected \$ 12.1 million or 90% of budget. We are now slightly below last year's collections of 91 % of budget at the same time period, but are staying on track.

- County Sales Tax- FY 24 Budget is \$ 1,600,000 which is 8.7% of total budget

Through 02/29/2024 we have collected \$ 816 K or 51% of budget. At the same point last year we had collected 58% so we are slightly below last year. However, we are averaging \$ 168.6 K per month and if this rate remains consistent for the remainder of the fiscal year we should exceed budget.

- DMV and Tax Assessor Fees- FY 24 Budget \$ 940K which is 5% of total budget

The Texas Comptroller remits a portion of the vehicle registration fee and the optional \$ 10 road and bridge fee to the County. Through 02/29/2024 we have collected \$ 404K or 44% of the total budget. The Motor Vehicle Registration reimbursement from the state started in January 2024 and we received an additional \$ 144K in February.

General Fund Expense:

- With the following exceptions, all departments are at or above 58% of their remaining budget:

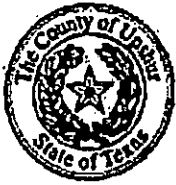
- **Computer- Annual Software Maintenance Fees are paid at beginning of the fiscal year.**
- **District Clerk-supply purchases for binders, files, storage and copy paper. Additionally, budgeted funds were transferred to cover educational costs.**
- **Elections- Lease payment for new election equipment was paid in December.**
- **Appraisal District- We have invoices for the first and second quarter of our annual fee.**
- **Sheriff's Office- Invoices totaling \$ 222 K (all budgeted) were paid in January for the purchase of 3 Chevy Tahoe's and 2 Chevy Silverados.**
- **Library- total budget for Library materials is \$ 45,000. Through February 29, the library has expended 25.9K or 42 % of total budget**

Insurance Fund

As of February 29, I am pleased to report that we are now receiving weekly claims runs from our new Administrator. Additionally, in February we paid claims totaling \$ 1,062,288 for which we had received payment from our Stop Loss Insurance.

Pooled Cash Report

As of February 29, 2024, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 30,568,404.33 of this amount \$ 23,013,269.66 belongs to the General Fund and \$ 7,555,134.67 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)
