After all parties in interest and the public had the opportunity to be heard the Upshur County Auditor's salary was set and is HEREBY ORDERED to be set at \$65,800.08 annually and the Assistant Auditors' salaries were set and are HEREBY ORDERED to be set at \$43,800.00 annually. The Salary of the 115th District Court Reporter is set at \$80,200.00 annually.


