DISTRICT CLERK DAILY DEPOSIT

Each day the District Clerk's Office submits a "District Clerk Daily Deposit" report (from the previous day) to the Treasurer's Office to support the total amount of funds received and remitted for deposit in Upshur County's operating bank account. Attached to the cover sheet is a "Distribution Report" generated from NetData for the specified deposit date which lists all transactions by type of fee. The total per the "Distribution Report" should equal the total deposit noted on the cover sheet. Also attached is a "Receipts and Direct Deposit Report" that lists all receipts by type of payment (direct deposit credit card, e-file credit card or cash).

The Auditor's Office selected for review the "District Clerk Daily Deposit Report" for August 21, 2024 prepared by Nicole Hernandez and submitted to the Treasurer's Office on August 22, 2024. A copy of the report is attached as Appendix 1 to this report. The total deposit was \$ 466.00 and per the distribution report, of that total, \$ 105 pertained to passport processing fees which are assessed on all passport applications (excluding renewals) at \$ 35.00 per application.

The "Receipts and Direct Deposit Report" showed a reversal, posted by Ms. Hernandez, for two passport processing fees (receipt number 069410) in the amount of \$ 70.00. Ms. Hernandez did not post the original transaction just the reversal and the reversal was entered the next day on 08/22/2024 with a post date of 8/21/2022.

The Auditor's Office requested a copy of the "US Department of State" passport transmittal logs maintained by the District Clerk's Office for 08/21/2024 and those logs are attached as *Appendix* 2 to this report. The logs show that there were five (5) passports transmitted on that date (with documented USPS tracking numbers) that were assessed a \$ 35 execution fee which would total \$ 175.00 in fees. This yields a \$ 70.00 variance to the report submitted after the transaction reversal by Ms. Hernandez.

Additionally, the Auditor's Office requested a copy of the individual receipts for 08/21/2024 and a copy of those receipts are attached to this report as *Appendix 3*. The receipts are by individual's name, description of fee type, pay type (cash, credit card, e-file) and amount. Total receipts by type per the individual receipts were:

Passport Processing (credit card) - \$ 70.00
Passport Processing (cash) - \$ 105.00
E-File Transactions - \$ 347.00
Copies (Cash) - \$ 14.00
Total per receipts \$ 536.00

Total Deposit <u>- \$ 466.00</u>

Shortage - \$ 70.00

Based on further research and statements by two district clerks to the Auditor's Office, there were a total of five (5) passports applications processed on 8/21/2024. Three (3) of the application fees were paid by credit card (\$ 105) and two (2) application fees were paid with cash (\$ 70.00). One couple paid the \$ 70.00 with a \$ 100.00. Ms. Hernandez gave the couple \$ 30.00 in change from one clerk's change bag and took the \$ 100.00 bill to the bank to exchange. Ms. Hernandez

reimbursed the \$30.00 to the clerk's bag, however the remaining \$70.00 was not placed into a bag for inclusion in the daily deposit submitted to the Treasurer on 8/22/24.

On August 27, 2024 the Auditor's Office met with Ms. Hernandez to verify the facts outlined in this report and to obtain any additional information or clarification she would like to communicate. Rather than providing additional information or clarification she became extremely distraught, admitted that she had reversed the transaction because in her words "she couldn't find the money." Ms. Hernandez continued to yell, stating that "you can prosecute me if you wish, I am quitting you can keep this (expletive) job." She then stormed out of the building.

١

Conclusion: The paper trail and statement made by district clerk staff indicate that the deposit for 8/21/2024 to the County Treasurer was \$ 70.00 short. This was not indicated on the daily deposit prepared by Ms. Hernandez and in fact it appears that a valid transaction for \$ 70.00 was reversed by Ms. Hernandez in an attempt to show that the total deposit was correct.

Section 37.10 (1) of the Criminal Code (Tampering with Governmental Record) states that a person commits an offense if he knowingly makes a false entry in, or false alteration of a government document. The general ledgers and subsidiary ledgers of Upshur County would be considered government documents.

CHANGE FUNDS

On August 13, 2024, the Upshur County Auditor's Office conducted an unannounced internal audit of the change funds maintained by the Upshur County District Clerks office. At the time of the audit, there had been no money receipted, therefore, no reports were generated.

Historically, the District Clerk's office has had four cash bags and one cash box all maintaining a \$ 50.00 balance. The Auditor's Office counted four cash bags and inquired about the location of the cash box. Ms. Hernandez, Upshur County District Clerk found the cash box and showed that there was no money in it and stated the District Clerk's Office no longer used the cash box. When asked about the remaining \$ 50.00 issued to the District Clerk's Office, Ms. Hernandez stated there were no additional funds in the office. The Auditor's Office showed Ms. Hernandez the worksheets from the last audit, with her signature, totaling \$250.00.

Ms. Hernandez then stated that she remembered taking money to get stamps because the postage machine was out of postage and she needed to send out jury summons. An audit worksheet was completed reflecting the missing money and Ms. Hernandez signed it.

The Auditor's Office requested a copy of the postage receipt to properly reconcile the change fund and reimburse the change from the postage expense account. Ms. Hernandez responded that the expenditure occurred back in early June and she was sure she no longer had the receipt. Ms. Hernandez was sent a copy of a Missing Receipt Affidavit to complete and it is attached to this report as Appendix 4.

We noted that the date of purchase noted on the original missing receipt affidavit is July 28, 2024 which was a Sunday and different from the original explanation provided in an e-mail dated August 13, 2024 which state the purchase was made "at the beginning of June." When contacted on the discrepancy, the District Clerk sent a corrected affidavit with the date changed to June 28, 2024 attached to this report as *Appendix 5*.

On August 19, 2024 the Auditor's Office met with Ms. Hernandez to gain additional information regarding the missing receipt, the questions and responses follow:

- 1. Question: "Do you recall the particular bulk mailing in June that required the use of the petty cash funds?"
 - Response: "No, however we do one monthly bulk mail out of approximately 350 mail outs."
- 2. Question-"Is there anyone else in the office that can corroborate the events as described and the need to use petty cash to supplement the required postage."

 Response: "Yes, my Chief Deputy Clerk. Mellissa Chevalier."
- 3. Question-"Do you recall the exact amount of the postage which came from petty cash, at \$ 0.68/stamp it would be impossible to use exactly \$ 50.00"

 Response: "No, we were able to cover the majority of the postage using the meter before the balance was depleted, I had to buy stamps for the remainder."
- 4. Question-" Why didn't you use one of the other available postage machines located in the Tax Office, the County Court, JP 1 or JP 3?" Response-"I didn't know that was an option until I spoke with Janice in the District Court Office."
- 5. Question-"Why are daily cash count slips verifying end of day reconciliations not present in the change funds."

 Response-"I was not aware these existed, but will implement that as soon as possible and will draft a form if there is not a generic form."

On August 27, 2024 the Auditors Office did meet with two clerks in the District Clerk's Office and neither of them could corroborate a specific bulk mailing which necessitated taking \$ 50.00 to the post office for postage.

On August 27, 2024 the Auditor's Office performed a second change fund cash count and found that the District Clerk's Office had again a shortage of \$ 50.00. Auditor's count attached as Appendix 6.

ISSUES

- 1. Reversal of a valid receipt transaction in order to agree the accounting reports to the total deposit is financial manipulation and considered Tampering with a Government Document under Section 37.10.(1) of the Criminal Code.
- 2. Based on the events as detailed on August 21, 2024 the person last in possession of the \$100.00 cash payment for the two passport fees, as documented by the receipt and passport log, was Ms. Hernandez.
- 3. Section 1 C-1 of the Upshur County Personnel Policy Manual states that "Personnel use of county equipment, supplies, tools, and other county property is not permitted and may result in discipline up to and including termination. Improper use may subject you to criminal prosecution. Theft of property when the value is between \$ 50.00 and \$ 500 is a Class B Misdemeanor in the State of Texas.
- 4. It is impossible for the Auditor's Office to verify the exact amount of postage to expense given the uncertainty of the actual amount.

RECOMMENDATIONS

- 1. The Auditor's Office will purchase 5 separate locking cash boxes that will be assigned to each of the four (4) clerks and district Clerk which will maintain a balance of \$ 50 each.
- 2. Each person should place all funds they receive in cash, check or money order payable to Upshur County in their assigned cash box.
- 3. At the end of each day, each cash box should be reconciled to the daily receipts and the reconciliation should be documented on a reconciliation form and signed by the cash box holder and countersigned as correct by another clerk after reviewing the reconciliation.
- 4. Funds in excess of the \$ 50.00 change fund balance should be remitted to the individual who will be preparing and delivering the Daily Report and deposit to the Treasurer's Office. The total deposits should then be placed in the safe until remittance to the Treasurer's Office.
- 5. All transaction reversals should be completed by the clerk who originally entered the transaction and signed explanation for the reversal should be included with the daily deposit report.
- 6. Should a clerk need to make change, they can request change be made from another clerk so that the transaction can be verified.

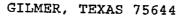
