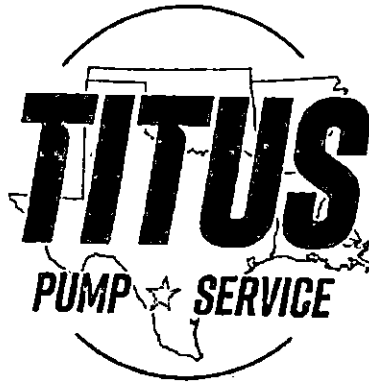

Quote to remove and leave on site 3 existing 10k above ground storage tanks. Quote does not include removing and re-installing cat walk (customer responsible for cat walk). Inside earthen dike install 2 each 3'x3'x25' reinforced concrete beams to set 2 new 10,000 gallon double wall above ground storage tanks. Anchor tanks to concrete footers and ground tanks. Install 2 remote fill boxes on concrete pads with 2 per fill box guard post, install overflow prevention valve in each tank, install overflow alarm and tank interstice alarm with alarm located at fill boxes, re-install product piping to pumps and customers tank monitoring device. This quote includes cleaning tanks with up to 500 gallons of waste (customer will need to empty product from tanks). Quote does not include any soil sampling.

Tank removal: All tanks must be empty prior to removal to avoid additional pump and disposal charges, the quote allows for up to 500 gallons of waste pump and disposal.  
 Underground Hazard Clause: Should, Rock, Water, Excessive caving, Underground utilities or other obstruction be encountered that impedes the installation of materials, the customer will be responsible to correct these issues and customer is responsible for additional charges to correct these issues.  
 Tank and material warranty: Titus Pump Service and affiliates provide a one year workmanship warranty only. All material including tanks are covered through the manufactures warranty. Customer is responsible for the materials warranty. Customer furthermore agrees to all materials used on project and accepts responsibility for material used and its manufactures warranty.  
 Ballast: Customer is responsible for tank ballast and hydro testing water. If water is used Titus pump will pump water from tanks and containment sumps, Customer understands that this is not a tank cleaning and if customer request a tank cleaning company to clean tanks then customer is responsible for all charges associated with the tank cleaning. Customer understands that steel tank manufactures recommend not leaving water in tanks for longer than 60 days.  
 Payment Terms: 50% of total invoice due at time of order, 75% of balance due when tank is set, balance due on completion and must be paid before any closing documents are released or fuel can be dispensed.
