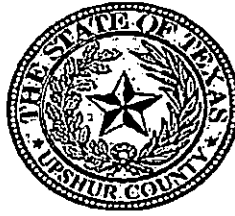

FINANCIAL HIGHLIGHTS

As of November 30, 2024 we have 10 months or 83.33 % of the year remaining

General Fund Revenue:

Ninety percent (90%) of the total general fund budgeted revenue comes from three categories; Property Tax, DMV Fees and Sales Tax, so it is critical that we stay on target in those three areas.

- Current Taxes and penalties- FY 25 Budget is \$ 14,814,983 which is 76% of total budget

Through 11/30/2024 we have collected \$ 1.2 million or less than 8% of budget. There was a delay in sending out tax statements so I will be watching the amount collected in December and January to determine if we are projected to meet budgeted revenue. At this time last year we had collected 11% of budgeted property tax revenue.

- County Sales Tax- FY 25 Budget is \$ 1,700,000 which is 8.7% of total budget

Through 11/30/2024 we have collected \$ 308K which is slightly less than 9% of total budget. If monthly sales tax collections remain consistent, we should meet our targeted budget.

- DMV and Tax Assessor Fees- FY 25 Budget \$ 940K which is 5% of total budget

The Texas Comptroller remits a portion of the vehicle registration fee which we typically start receiving in January, thus we are below budget currently.

General Fund Expense:

- With the following exceptions, all departments are at or above 83 % of their remaining budget:

- Computer- Four (4) annual software maintenance fees were paid in October and November: Tyler Tech Enterprise Management; Tyler Tech Incode Financial Management; Netdata and Tritech Software.
- District Attorney- the new vehicle budgeted for the District attorney's office was purchased in October.
- Appraisal District- The 1st Quarter entity payment was made in November.
- Library- total budget for Library materials is \$ 45,000. Through November 30, the library has expended 12.3K or 29% of total budget.

Insurance Fund

As of November 30, 2024 claims paid totaled \$ 391K which is higher than the annualized budget. Prescription claims totaled \$ 99 k which is also higher than the annualized budget. If claims continue at this level for the next ten months, we will be approximately 750K overbudget.

I received an e-mail from Rachel Means with EBC this morning and she said that claims coming in now are back down to last year levels. Additionally, we have received very positive feedback on those employees signed up for Pulse Direct and we are in hopes that this will decrease claims expense in the upcoming months.

Pooled Cash Report

As of November 30, 2024, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 23,574,648 of this amount \$ 16,448,663 belongs to the General Fund and \$ 7,125,985 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)
