## COMMISSIONERS COURT OF UPSHUR COUNTY, TEXAS WEDNESDAY, NOVEMBER 27, 2024 10:00 A.M. REGULAR SESSION

A regular meeting of the Commissioners' Court of Upshur County, Texas was held on Wednesday, November 27, 2024 at 10:00 a.m., with the following members of the Court being present, to-wit:

Judge Tefteller called the regular meeting to order at 10:01 a.m.

- 2. Citizen comments. None
- 3. Consider and take action on approval of:
  - A. The minutes of previous meetings;
  - B. Payroll changes;
  - C. Payroll;
  - D. Budget amendments;
  - E. Accounts Payable;
  - F. Accept for recording: Auditor report; Treasurer reports; Bonds; Oaths; Deputations; Certificates; State and County Taxes Summary; refund of overpayment or erroneous tax payments in excess of \$2500.00; and, applications for use of Upshur County roads and rights-of way and permit requests.

4. Hear any updates and discuss and take necessary action concerning the Round XII Courthouse Grant Renovation and/or the Courthouse employee relocation during the renovation.

Judge Tefteller announced that Judge Leward LeFleur could not make the meeting but he

announced that the renovation was running on schedule.

### 5. Discuss and take action to accept for recording the plat for Thomas Subdivision.

# 7. Discuss and take action to sign a letter of support of the Texas Railroad Association urging the Texas Legislature to fund TxDOT's under and overpass railroad crossings, i.e., local grade separation projects.

Miller to authorize Judge Tefteller to sign a letter of support of the Texas Railroad Association urging the Texas Legislature to fund TxDOT's under and overpass railroad crossings, i.e., local grade separation projects. Motion carried 5-0. Unanimous vote in favor.

# 8. Hear from the Road & Bridge Administrator with an update of the County roads in each precinct.

Phil Stegall, Upshur County Road and Bridge Administrator, announced to the Court that they have been working on tree issues, ditch and overlay, dead trees, maintenance on equipment, and work orders. He further announced that he should receive the new fuel tank in February or March.

## 9. Discuss and take action to approve the Kroger Settlement, within the Texas Opioid multidistrict litigation case, as well as authorizing the County to execute the Participation Form and Release and passing the Resolution (2024-13) approving the same.

Judge Tefteller recused himself from presiding and taking action on this matter and advised that he had filed the appropriate conflict affidavit with the County Clerk. Judge Tefteller left the courtroom at 10:12 a.m. Dustin Nicholson, Precinct 2 Commissioner, will preside over this matter. Motion by Gene Dolle with a second by Mike Ashley to approve the Kroger Settlement and authorized the County to execute the Participation Form and Release and passed the Resolution (2024-13) approving the same. Motion carried 4-0. Unanimous vote in favor. PLEASE NOTE THAT THE RESOLUTION WAS NOT FILED OF RECORD PER JUDGE TEFTELLER.
