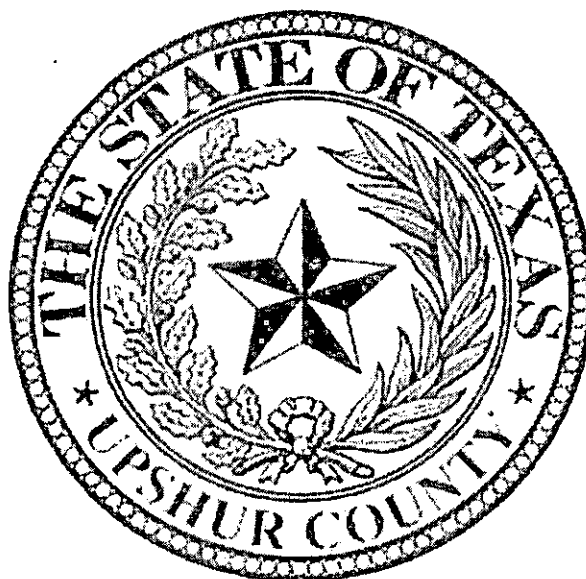

FINANCIAL HIGHLIGHTS

As of January 31, 2025 we have 8 months or 67 % of the year remaining

General Fund Revenue:

Ninety percent (90%) of the total general fund budgeted revenue comes from three categories; Property Tax, DMV Fees and Sales Tax, so it is critical that we stay on target in those three areas.

- Current Taxes and penalties- FY 25 Budget is \$ 14,814,983 which is 76% of total budget

Through 01/31/2025 we have collected \$ 11.6 million or 78% of budget. We collected \$ 7.4 million in the month of January. To meet our targeted budget we will need to collect an additional \$ 3.2 million during the remainder of the year.

- County Sales Tax- FY 25 Budget is \$ 1,700,000 which is 8.7% of total budget

Through 01/31/2025 we have collected \$ 626K which is 37% of total budget, so we are on budget at this time. If monthly sales tax collections remain consistent, we should remain at targeted budget. At the same time last year we had collected slightly more at \$ 632 K.

- DMV and Tax Assessor Fees- FY 25 Budget \$ 940K which is 5% of total budget

We have just started to receive our portion of the vehicle registration fee, and collected \$ 36 K in January from the Texas Comptroller.

General Fund Expense:

- With the following exceptions, all departments are at or above 67 % of their remaining budget:
 - Computer- Four (4) annual software maintenance fees were paid in October and November: Tyler Tech Enterprise Management; Tyler Tech-Incode Financial Management; Netdata and Trittech Software.

- District Attorney- the new vehicle budgeted for the District attorney's office was purchased in October.
- Elections- The annual lease payment for the new voting equipment was made in December and represents a large portion of the departmental budget.
- Tax Assessor- Payments to Peregrine for tax statements, mailings and envelopes were posted in November and December.
- Sheriff's Office- We paid out accrued vacation and comp time for four (4) employees for a total of \$ 34 K through 1.31.25. Additionally, the software maintenance for the body cameras was paid.
- Library- total budget for Library materials is \$ 45,000. Through January 31, the library has expended 23K or 52% of total budget.

Insurance Fund

Unfortunately, the Insurance Fund is on path to potentially be over budget \$ 300-400K

As of January 31, 2025 insurance claims paid totaled \$ 664K which is an average of \$ 166K per month. Although we experienced a slight decrease in December, claims in January were back up, if claims continue at this level for the next eight months, we will be approximately \$ 350K over budget.

As of January 31, 2025 prescriptions paid totaled \$ 201K which is an average of \$ 50K per month. If claims continue at this level for the next eight months, we will be approximately 150K overbudget.

Pooled Cash Report

As of January 31, 2025, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 32,376,913.65 of this amount \$ 25,495,370.23 belongs to the General Fund and \$ 6,881,543.42 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)
