FINANCIAL HIGHLIGHTS

As of February 28, 2025 we have 7 months or 58 % of the year remaining

General Fund Revenue:

Ninety percent (90%) of the total general fund budgeted revenue comes from three categories; Property Tax, DMV Fees and Sales Tax, so it is critical that we stay on target in those three areas.

- Current Taxes and penalties- FY 25 Budget is \$ 14,814,983 which is 76% of total budget

Through 02/28/2025 we have collected \$ 13.5 million or 91% of budget. We collected \$ 1.9 million in the month of February. To meet our targeted budget we will need to collect an additional \$ 1.3 million during the remainder of the year.

- County Sales Tax- FY 25 Budget is \$ 1,700,000 which is 8.7% of total budget

Through 02/28/2025 we have collected \$ 835K which is 49% of total budget, so we should meet our targeted budget.

- DMV and Tax Assessor Fees- FY 25 Budget \$ 940K which is 5% of total budget

We have just started to receive our portion of the vehicle registration fee, and collected \$ 318K in February from the Texas Comptroller.

General Fund Expense:

- With the following exceptions, all departments are at or above 58 % of their remaining budget:

- Computer- Four (4) annual software maintenance fees were paid in October and November: Tyler Tech Enterprise Management; Tyler Tech Incode Financial Management; Netdata and Trittech Software.

- District Court- Capital murder trial expenses total \$ 27K through the month of February.
- District Attorney- the new vehicle budgeted for the District attorney's office was purchased in October.
- Elections- The annual lease payment for the new voting equipment was made in December and represents a large portion of the departmental budget.
- Tax Assessor- Payments to Peregrine for tax statements, mailings and envelopes were posted in November and December.
- Sheriff's Office- We paid out accrued vacation and comp time for four (4) employees for a total of \$ 34 K through 2.28.25. Additionally, the software maintenance for the body cameras was paid and 89% of the uniform budget has been spent through the month of February.
- Library- total budget for Library materials is \$ 45,000. Through February, the library has expended 27K or 60% of total budget.

Insurance Fund

Unfortunately, the Insurance Fund is on path to potentially be over budget more than previously expected. Over the five (5) months ended 02/28/2025 the average monthly claim total was \$ 190K. If this remains consistent for the remaining seven (7) months we will be \$ 580K overbudget.

As of February 28, 2025 prescriptions paid totaled \$ 239K which is an average of \$ 47.8K per month. If claims continue at this level for the next eight months, we will be approximately 124K overbudget.

Total expected amount exceeding budget for claims and prescriptions is \$ 704K

Pooled Cash Report

As of February 28, 2025, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 33,436,892.01 of this amount \$ 26,894,368.90 belongs to the General Fund and \$ 6,542,523.11 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)
