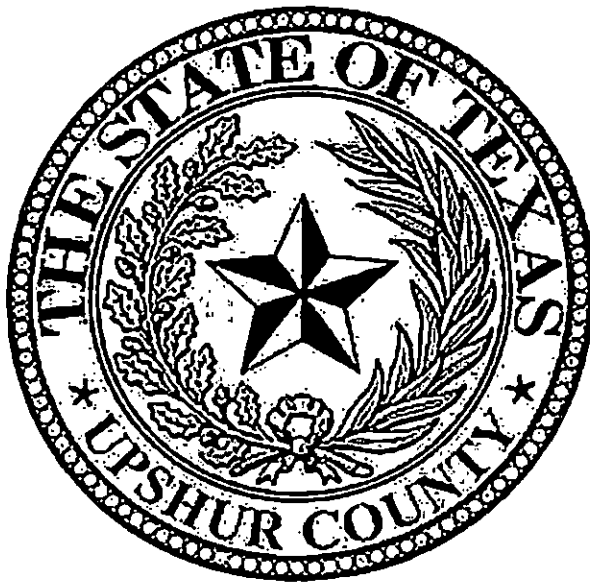

FINANCIAL HIGHLIGHTS

We are at the half-way mark for FY 25, as of April 30, 2025 we have 5 months or 41 % of the year remaining

General Fund Revenue:

Ninety percent (90%) of the total general fund budgeted revenue comes from three categories; Property Tax, DMV Fees and Sales Tax, so it is critical that we stay on target in those three areas. The good news is that it appears we will meet or exceed our budget in several categories.

- **Current Taxes and penalties- FY 25 Budget is \$ 14,814,983 which is 76% of total budget**

Through 04/30/2025 we have collected \$ 14.2 million or 97.5% of budget. We collected \$ 335K in the month of April. To meet our targeted budget we will need to collect an additional \$ 365K during the remainder of the year.

- **County Sales Tax- FY 25 Budget is \$ 1,700,000 which is 8.7% of total budget**

Through 04/30/2025 we have collected \$ 1.1 million which is 66% of total budget, so we should meet our targeted budget.

- **DMV and Tax Assessor Fees- FY 25 Budget \$ 940K which is 5% of total budget**

We have collected 100% of the budgeted \$ 360K for motor vehicle registration fees and 33% of the targeted budget in tax assessor fees.

- **Out of County Prisoner Reimbursement Fees have exceeded budget by \$ 40. K as of 04/30/2025.**

General Fund Expense:

- With the following exceptions, all departments are at or above 41 % of their remaining budget:
 - Computer- Four (4) annual software maintenance fees were paid in October and November: Tyler Tech Enterprise Management; Tyler Tech Incode Financial Management; Netdata and Tritech Software.
 - Elections- The annual lease payment for the new voting equipment was made in December and represents a large portion of the departmental budget.
 - Library- total budget for Library materials is \$ 45,000. Through April, the library has expended 34K or 77% of total budget.

Insurance Fund

Unfortunately, the Insurance Fund continues on path to be over budget more than previously expected. Over the seven (7) months ended 04/30/2025 we have paid \$ 1.2 Million in claims, with the average monthly claim totaling \$ 172K (a slight decrease in average over prior month). If this remains consistent for the remaining five (5) months we will be \$ 400-500K overbudget.

As of April 30, 2025 prescriptions paid totaled \$ 299K which is an average of \$ 42.7K per month (a slight decrease in average over prior month). If claims continue at this level for the next six months, we will be approximately 62K overbudget.

The good news is we are seeing a slight decrease in both claims and prescription costs, however we will likely exceed budget for claims and prescriptions by \$ 540K.

Pooled Cash Report

As of April 30, 2025, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 32,655,240.21 of this amount \$ 26,561,387.71 belongs to the General Fund and \$ 6,093,852.50 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)

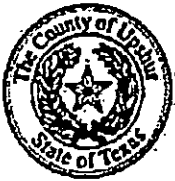
