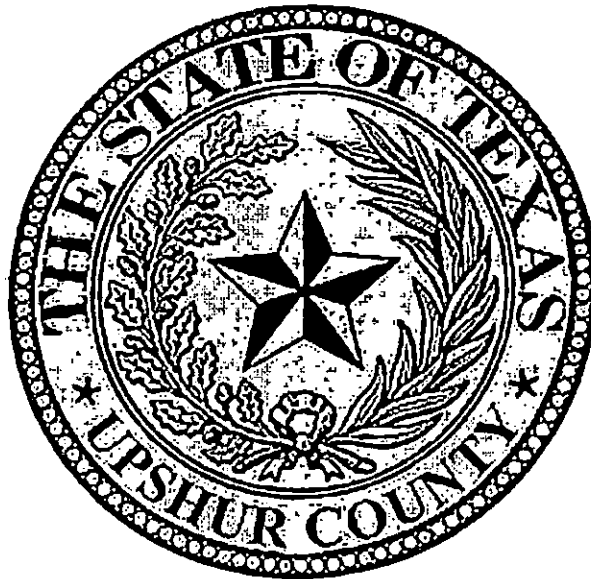

FINANCIAL HIGHLIGHTS

As of August 31, 2025 we have 1 months or 8.33 % of the year remaining.

General Fund Revenue:

Ninety percent (90%) of the total general fund budgeted revenue comes from three categories; Property Tax, DMV Fees and Sales Tax, so it is critical that we stay on target in those three areas. The good news is that it appears we will meet or exceed our budget in several categories.

- Current Taxes and penalties- FY 25 Budget is \$ 14,814,983 which is 76% of total budget

Unfortunately, up until this month it looks like we would meet the targeted budget, however it appears collections may be less than 100% so we will likely end the year approximately \$ 400K under budget. Through 08/31/2025 we have collected \$ 14.3 million or 97% of the general fund budget.

- County Sales Tax- FY 25 Budget is \$ 1,700,000 which is 8.7% of total budget

Through 08/31/2025 we have collected \$ 1.8 million and have exceeded budget by \$ 78K.

- DMV and Tax Assessor Fees- FY 25 Budget \$ 940K which is 5% of total budget

We have collected 100% of the budgeted \$ 360K for motor vehicle registration fees and over 122% of the targeted budget in tax assessor fees or \$ 69K more than budgeted.

- Out of County Prisoner Reimbursement Fees have exceeded budget by \$ 205 K as of 08/31/2025.

General Fund Expense:

- With the following exceptions, all departments are at or above 8.33 % of their remaining budget:
 - Computer- Four (4) annual software maintenance fees were paid in October and November: Tyler Tech Enterprise Management; Tyler Tech Incode Financial Management; Netdata and Trittech Software. In addition, the majority of the cost for the implementation of Tyler Technologies Court Management has been paid. Additionally, we are slightly over budget for maintenance costs due to added maintenance contracts.
 - Non-Departmental- Unemployment Compensation is over-budget \$ 6.7K due to an increase in claims. Postmortem Expenses are over budget \$ 6.5 K due to the increase in number of autopsies this year totaling 16 through the month of August. Property & General Liability Expense is over budget \$ 40K, although I budgeted for an average 9% increase in policy cost, actual cost was an approximate 15% increase. Finally, I transferred the \$ 2.2 million I budgeted in Contingency Courthouse Renovation to the THC Grant Fund 309 to go toward the County Match.
 - Appraisal District- We have made all quarterly payment for FY 25, thus we will actually be slightly under budget.
 - Library- total budget for Library materials is \$ 45,000. Through August, the library has expended 45.7 K or K or 98% of total budget.

Insurance Fund

The Insurance Fund is continues to have a very bad year. Insurance claims for the month of August totaled \$ 95 K and prescription claims totaled \$ 47.5K. Over the ten (11) months ended 08/31/2025 we have paid \$ 1.9 million in claims, with the average monthly claims at \$ 180K. If this remains consistent for September we will be \$ 400K over budget for medical claims and \$ 150K over budget for prescriptions.

Pooled Cash Report

As of August 31, 2025, total Cash Balance in all accounts combined (excluding the Insurance Fund and School Funds) was \$ 28,068,383.65 of this amount \$ 21,050,717.77 belongs to the General Fund and \$ 7,017,665.88 belongs to our Dedicated Funds (Grants, CSCD, Juvenile Probation, and legally dedicated funds.)

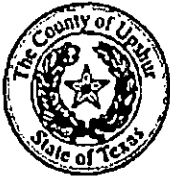
