Proposed Budget. 1) She requested to move \$100,000 from the Courthouse Renovation Contingency County Match to Contract Services Mitigation; and 2) She requested an increase in stipends for the two Juvenile Board Judges by \$1,800 each. Motion by Commissioner Dolle with a second by Commissioner Ashley to approve the changes as requested. Motion carried 4-0. Unanimous vote in favor.

5. Discuss and take action to schedule the Public Hearing on the Tax Increase (any rate above the No-New Revenue rate) for September 15, 2025 at 10 a.m.

9. Hear from the Road & Bridge Administrator with an update of the County roads in each precinct.

Phil Stegall, Road and Bridge Administrator, informed the Court that his department has completed 14 miles of road divided between each of the precincts.

10. Discuss and take action to approve a contract with Kofile to preserve Deed Records Volumes D-P in the amount of \$50,969.34 to come from the County Clerk Records Preservation Fund.

Terri Ross, Upshur County Clerk, presented a contract to the Court for preservation of old Deed Records Volumes D-P in the amount of \$50,969.34 from Kofile with funds generated from the County Clerk Records Preservation Fund. Motion by Commissioner Dolle with a second by Commissioner Ashley to approve the contract with Kofile to preserve Deed Records Volumes D-P in the amount of \$50,969.34 to come from the County Clerk Records Preservation Fund. Motion carried 4-0. Unanimous vote in favor.
